2017 in Review

s we start off 2018, it's a good time to take stock of where we have been, what we've done, and what the future may hold! The following statistics paint a picture of the HLA Library's activities in 2017:

- ➤ 30,872: Number of people who came through our doors
- > 1,830: Number of books reshelved in the Library

- 236: Number of books signed out
- ➤ 1,149: Total number of questions responded to by HLA Library Staff
 - > 480 received by telephone
 - > 305 received by email
 - ➤ 360 received in person
 - ➤ 3 received by fax

- > \$143,557: Dollars spent on books and library subscriptions (print and online)
 - > \$108,085 on looseleaf subscriptions
 - > \$22,835 on textbooks

As you can see, the vast majority of our budget was spent on maintaining our looseleaf subscriptions, which continue to rise in cost each year. We also renewed our subscriptions to online services like Lexis Practice Advisor, RangeFindr, and DIVORCEmate.

Finally, we acquired lots of fantastic new titles for our collection (266 in fact!).

The LCO's project examines the underlying purpose and function of defamation law and considers how defamation law should be updated to account for "internet speech," including social media, blogs, internet platforms and digital media. The project is the most comprehensive analysis of Ontario's defamation law framework to date.

The LCO is Ontario's leading law reform agency. Its role is to conduct research, undertake public consultations, and develop reports and recommendations to improve the effectiveness, relevance and accessibility of the law. The LCO is committed to a broad consultation process to reflect the full diversity of Ontarian perspectives and experiences. Currently, we are seeking to consult with practitioners who have had some experience with defamation law and individuals who have been personally involved in a defamation dispute. Legal Research Tips

Charterpedia: New, Fabulous, and Free!

The Department of Justice recently launched a new website called Charterpedia, which "contains information about the purpose of each section of the Charter, the analysis or test developed through case law in respect of the section, and any particular considerations related to it." Each entry provides case citations, with hyperlinks to the full text of SCC decisions.

LexisAdvance Quicklaw: Explore Content

One of the biggest gripes we have heard (and experienced ourselves) with LexisAdvance Quicklaw is the inability to conduct a targeted, narrow search. LexisNexis has taken some steps to correct this with the new "Explore Content" menu on the homepage. You can now select a specific type of content (court cases, tribunal decisions, and Halsbury's are available now, with more to come) and search specifically within that database. On the Advanced Search page for each content type, a variety of specific fields are available. For cases this includes name, citation, date, jurisdiction, judge, and counsel.

Getting used to a new website can be cumbersome, but it is encouraging that LexisNexis is listening to customer feedback and trying to improve this product. If you have any issues or questions about using LexisAdvance Quicklaw, feel free to contact the HLA Library to help sort them out! ■
